All Nat. Status entries are considered provisional pending payment of entry fees (AED 2,400 Race Entry fee / AED 2,715 including testing for Registered UAE Touring Car Championship competitors; AED 2,900 Race Entry fee / AED 3,320 including testing for Non-Registered UAE Touring Car Championship Competitors). Registration and Payment shall be made online through the appropriate channel or via credit card, in cash or by cheque by coming to Dubai Autodrome (Sunday – Thursday, 09:00 – 17:00).

Eligible Competitors

All competitors must be holders of current, valid and relevant National Race License from a recognized ASN. All competitors must have passed the appropriate Medical and meet any other requirements applicable to the event, its status and/or championship or race/event in question. In addition, the competitors must have permission to compete from their license issuing ASN in accordance with Article 70 of the ISC of the FIA. Licenses, Medical Certificates and permissions will be examined at signing-on.

Close of Entries

Entries close at 17:00hrs on **Monday, 11th february 2019.** Late Entries MAYBE considered with a late entry fee of AED 500, subject to the Championship organizers written approval. No entries whatsoever will be accepted after 17:00hrs, **Wednesday, 13th February 2019.**

Scrutineering Etc:

All vehicles must comply with Vehicle, Formula and tire regulations. In accordance with Article 128 of the Code, all vehicles must have suitable and sufficient protection for the prevention of passage of flame between engine and driver's seat.

All competitors are insured in respect of Third Party Public liability during official testing, practice and racing. They are strongly advised to make their own arrangements with regard to personal accident/injury cover and cover for damage to their vehicles and those of other competitors taking part.
